Environmental Assessments for Seismic Operations

PUBLIC NOTICE

The Texas Mid-Coast National Wildlife Refuge Complex has announced that Environmental Assessments on proposed 3D seismic surveys across the portions of San Bernard National Wildlife Refuge are available for public review and comment until June 18, 2008.

Two areas of the Refuge are covered by these assessments:

- **The eastern side of San Bernard National Wildlife Refuge.**

This assessment relates to an application for a Special Use Permit that would allow Geokinetics USA, Inc. access surface lands of the Refuge for the purpose of conducting a 3D seismic survey of subsurface geological features. Data gathered from this survey will allow Geokinetics to effectively evaluate the hydrocarbon reserves underlying the project area. - **Dance Bayou Unit of San Bernard National Wildlife Refuge.**

This assessment relates to an application for a Special Use Permit that would allow Hawkeye Stratigraphic, Inc. and Eagle Geophysical, Inc. access to the surface lands of the Dance Bayou Unit (DBU) for the purpose of conducting a 3D seismic survey of subsurface geological features. Data gathered from this survey will allow HS, Inc. to effectively evaluate the hydrocarbon reserves adjacent to and underlying the DBU, while keeping the disruption of DBU at an absolute minimum.
