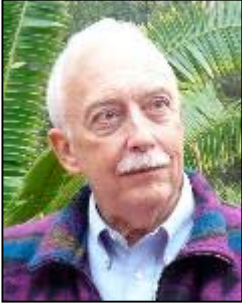

Many communities and organizations rely on such citizen volunteers for implementing youth education programs; for operating parks, nature centers, and natural areas; and for providing leadership in local natural resource conservation efforts. In fact, a short supply of dedicated and well-informed volunteers is often cited as a limiting factor for community-based conservation efforts.</p> <p>When the Phytoplankton Monitoring Network worked with the TPWD in 2007 to train new volunteers along the Texas coast, the Texas Master Naturalists answered the call. Nearly 30 TMN members attended the training sessions and helped establish over 20 new sampling sites. Currently the TMN PMN members do not just monitor for the program, but some members also conduct new volunteer trainings all along the coast. The TMN is playing a vital part in monitoring the Texas coast for potential Hazardous Algae Bloom (HAB) events.</p> <p>This training is approved for Advanced Training credit. It features searchable maps and instant information on bird watching, trails and historic sites. The app launched with 42 of the country's 555 national wildlife refuges, and more will be added in the future.

## Coastal Wetlands Grant

Press release from US Fish & Wildlife Service

WASHINGTON – January 3, 2012 – Secretary of the Interior Ken Salazar today announced \$20.5 million in grants to support 24 projects in 13 states to conserve and restore coastal wetlands and their fish and wildlife habitat. The grants, awarded under the 2012 National Coastal Wetlands Conservation Grant Program, will be matched by nearly \$21 million in partner contributions from state and local governments, private landowners and conservation groups.

"Coastal wetlands serve as some of nature's most productive fish and wildlife habitat while providing storm protection, improved water quality, and abundant recreational opportunities for local communities," Salazar said. "I am pleased that with these grants we are able to help our state partners implement some of their high-priority projects that support both conservation and recreation along their coasts."

The grants will be used to acquire, restore or enhance coastal wetlands and adjacent uplands to provide long-term conservation benefits to fish, wildlife and their habitat. States receiving funds include Alaska, California, Delaware, Florida, Georgia, Hawaii, Maine, Maryland, Massachusetts, New Jersey, Texas, Virginia and Washington.

The National Coastal Wetlands Conservation Grant Program is administered by the U.S. Fish and Wildlife Service and funded under provisions of the 1990 Coastal Wetlands Planning, Protection and Restoration Act. Funding is provided by Sport Fish Restoration Act revenue – money generated from an excise tax on fishing equipment, motorboat and small engine fuels.

The grants support President Obama's America's Great Outdoors initiative for conservation, recreation and reconnecting people to the outdoors. A recent 50-State Report lists more than 100 of the country's most promising projects – a result of 50 meetings with governors and stakeholders held by Salazar and other senior Interior officials to solicit ideas on how to best implement AGO in their states.

The Texas Parks and Wildlife Department was awarded a \$1 million grant to protect and restore coastal and estuarine barrier island habitats in West Galveston Bay along the north shoreline of Galveston Island, Texas. The project will restore approximately 70 acres of estuarine marsh complex, which will provide additional protection to the existing intertidal marsh that has been degraded by the effects of relative sea level rise.

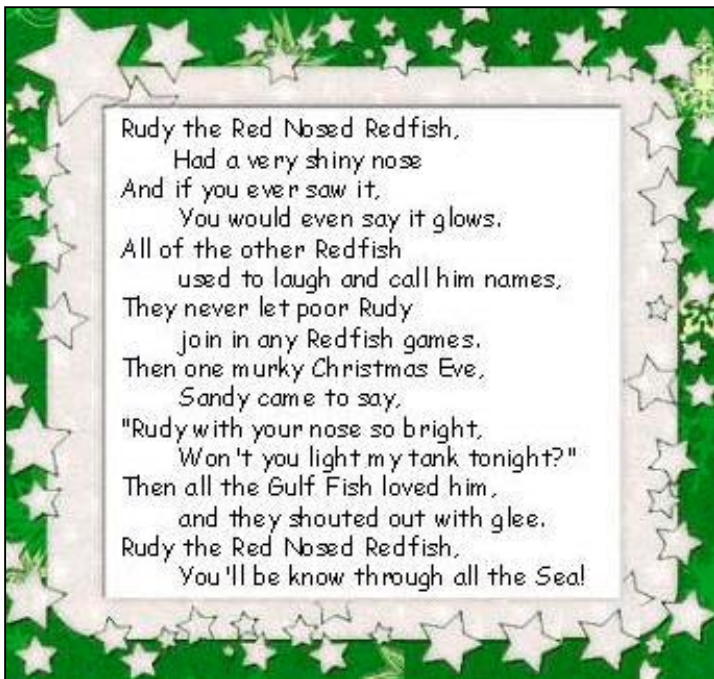

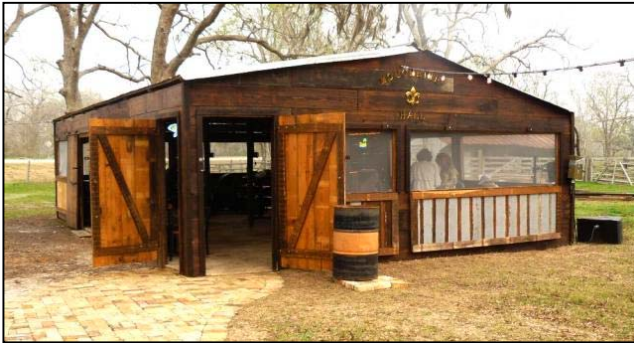
